
Subject :- Issuing Recognition certificate under section 18 of the 2009 (RTE) Right of Children to free and compulsory education, right of Children to free and compulsory education 2011, sub rule (4)

With reference to your application Dt. 01/08/2020, on the basis of our letter correspondence/inspection of the school, I, The Education Officer (Primary) Buldana District, hereby recognition to the above mentioned school for a temporary period of 3 years that is from 01/04/2020 to 31/03/2023 for classes from std 1<sup>st</sup> to std 8<sup>th</sup>

- 1) Period of recognition shall not be extended and in any condition for the affiliation or recognition after 8<sup>th</sup> std. there shall be no rustication.
- 2) The school shall be abide by the provision of the (RTE) right of Children to free and compulsory education, 2009 (joint letter 1) and for the children in Maharashtra, right of Children to free and compulsory education, 2011 (Joint letter 2)
- 3) The School shall provide free admission to 25% student belonging to the disadvantaged groups and weaker section according to the limit of the strength of its std 1 and shall not charge fees till the completion of their primary education and it shall be followed for the pre-primary education to.

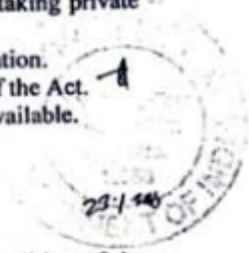
Forms should be called from the student belonging to the disadvantaged groups and weaker section in the vicinity 1 km.

- 4) Reimbursement shall be done in accordance to the clause mentioned in paragraph 3, section 12 (2). For this reimbursement school shall have separate and independent bank account.
- 5) The school/Management shall not impose any capitation fees nor shall keep any screening method or interviews for the parents seeking admission for their wards.
- 6) No child shall be denied admission in case he or she fails in producing document such as :- Age proof certificate, certificate showing religion, cast, heredity, creed or certificate of birth etc.
- 7)
  - a) No child, whosoever is admitted shall be retained in the same class not shall be sustained from the school until the completion of his/her primary education.
  - b) No physical or mental punishment shall be practiced.
  - c) No child shall be detained in any kind of exam held by any board until the completion of primary education.
  - d) On successful completion of primary education every child shall be given certificate of appreciation.

- e) Differently able and child with special need shall be included as per the rules provided.
- f) Minimum qualification teacher shall be appointed as per section 23 (1) of the Act. But the teacher appointed before the implementation date of the Act shall complete the condition of minimum qualification within five years.
- g) The teacher shall abide by all the rules and regulation as mention in the Act section 23 (1).
- h) It shall be strictly observed that any of the teacher is not involved in taking private tuition.
- 8) The school shall implement the syllabus designed by the authentic authorization.
- 9) The school shall be abide by rules and regulation mentioned in section 19 of the Act. At the time of inspection of above mention, following facilities should be available.
- Area of the school premises 10680 sq. mts.
  - Playground 500 sq. mts.
  - 24 class rooms.
  - Room for office, store and Head Master's office.
  - Separate and independent wash room for boys and girls where the condition of the wash room shall be clean and hygienic with necessary facilities.
  - Drinking water facilities (Bore)
  - Kitchen for cooking lunch. (not mandatory)
  - Teaching – learning equipments/sport equipments/ Library.
  - Reading material for reference availability.
- 10) Unrecognized classes or sections shall not be run in the premises.
- 11) The school building premises, construction or sport equipment shall be used only for the academic and skill development.
- 12) The school is run by the society registered under school registration act section 1860 (1860[21]) or Mumbai public Trust Act 1950.
- 13) The school not be run in any person's or private interest or financial accomplishment.
- 14) School audit shall be approved by a legally authentic C. A. and got the audited documents prepared.
- 15) Please see that you always mention your UDISE number of your school "27040906219" whenever communicating with this office.
- 16) The school shall readily produce the reports and information regarding compliance and observation of school recognition conditions, asked by the director of Education or District Education officer from time to time,
- 17) Whatever amendments, renovation in regard to society registration, shall be confirmed.


